SHF 13th Annual Gala Partner Selected

The Superior Health Foundation is pleased to announce that it has selected the Northern Lights Child Advocacy Center as its partner for the 2024 Annual Gala.

Based in Marguette, its mission is to help and serve all child survivors of physical and sexual abuse, neglect, human trafficking, and witness to violence. Children accessing its services are from all socioeconomic backgrounds, all races, genders, and from all parts of Marquette County and surrounding rural areas.

At least \$15,000 in funding from



the gala, scheduled for Saturday, Sept. 28, in the Ballrooms at the Northern Center, will be used to purchase supplies and technology vital to the services provided by the children's advocacy center.

These services include client intake and crisis counseling, forensic interviews, case coordination services, coordination of a multidisciplinary team including the prosecutor's office, law enforcement and children's protective services, and community prevention education. SHF Grants at Work



In April, the Superior Health Foundation awarded the Gogebic County Sheriff's Office a \$2,500 Equipment Fund grant for the purchase of two refurbished AEDs. Gogebic County is a rural county with a population of 14,380. However, it is a large county of 1,476 square miles. This large area makes it difficult on Beacon Ambulance's response times. The Gogebic County Sheriff's Office deputies respond to every medical emergency they are able to. From Aug. 1, 2023, to Dec. 14, 2023, the Gogebic County Sheriff's Office responded to 119 medical assists calls, and the new AEDs were readily available for use for all 119 calls.

In May, the Superior Health Foundation awarded Negaunee Public Schools a \$2,500 Pilot Project grant for the development of a garden at Lakeview Elementary School.

The Lakeview Garden is a school garden space shared and cared for by all Lakeview Elementary School staff and students. It is used for hands-on learning, farm to table food and education, and functional physical and sensory activities. The grant allows the garden to have a universally designed pathway which loops through the primary areas of the garden. It is an even surface to promote safe mobility.

Its width allows turn radius and space for
